
I, Adam D. Walter, declare as follows:

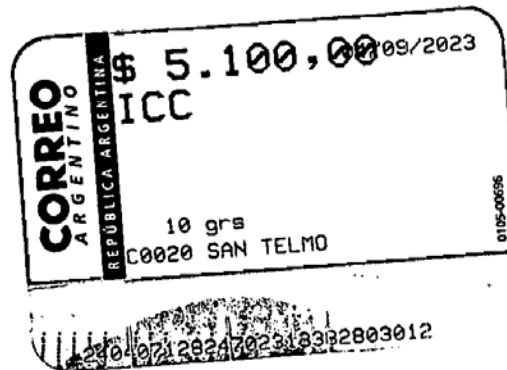

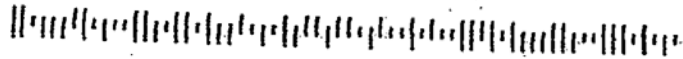
